11/20/2023 New Patch Phone Verbiage

As of today, when RN/Para answer the Patch phone at VVMC it is now "Y1100Debbie speaking" The only time a physician's name will be mentioned on the patch is if they have had input into Pre-Hospital care, namely:

- 1. Continue or cessation of resuscitation efforts
- 2. Refusals
- 3. Destination decisions i.e. SMC/FMC
- 4. Medication or treatment orders.

The reason behind this decision;

The verbiage of "Dr....standing by "places our physicians in a compromising situation as their name's are associated to patient's they have no knowledge of or input into.

11/01/2023 Dexamethazone

Kyler Lee, SFD, discovered while doing a refresher on the <u>Pediatric Stridor (e.g., Croup)</u> protocol, that we do not carry Dexamethasone on our drug boxes only Solumedrol. In consultation with Dr. Lotz, Dexamethasone will be added to the drug boxes, see his comments below:

"The American Academy of Pediatrics recommends Dexamethasone for the treatment of croup. This is because of its relatively fast onset, but longer duration than other steroids (36-54 hours for decadron vs 12 hours for solumedrol). This means that it's a onetime dose of steroids rather than needing a prescription. It is also easily administered as PO, IV or IM and the IV formulation can even be given orally (this is what we do in the hospital most of the time).

Oral prednisolone has been studied and is a second line therapy, but methylprednisolone (Solumerol) hasn't really been studied so it's hard to say the efficacy. IV solumedrol also requires an IV and the vast majority of these kids won't get one because it isn't needed.

I support expanding our drug box to include Dexamethasone, especially with cold and flu season here. If we were in a city with short transport times, I'd say it probably doesn't matter to add it as it takes 30 or so minutes to take effect. However, with our longer transport times, if given right away it would mean faster resolution of symptoms once in the ED and therefore less time in the ED. "

Pharmacy will be providing 2 X 4mg per 1ml vials for each drug box. Thank you

Good morning, Casey Rucker, NAH Security Director, is asking VVMC & Sedona Pre-Hospital Care agencies to help identify patients with weapons before transporting them to VVMC & SMC by asking/ stating the following: "VVMC & SMC are weapon free zones. Do you have any weapons on you?"

Asking a patient this question may have additional risks but it is something that EMS providers should be aware of and have as part of their agency safety plan. EMS providers should report any red flags to NAH security upon arrival at VVMC or staff at SMC.

Troy:

- 1) Walking Sick/Unstable Patients= Try and limit having patients walk if they re appearing extremely sick or unstable.
- 2) SMR= Review the SMR protocol. If they do not need spinal restriction then document appropriately. We are looking at getting soft c-collars.

- 3) STR's= Please send a list of all completed STR training. Troy has created one and emailed it out. Feel free to use this or create your own. If you can email it once all the departments STR training has been completed. Then it will be put in your department folder for records to show the state of training completion.
- 4) WRAP Device- The Cottonwood Police and Sedona Police departments have purchased new restraining devices. They are called the WRAP. Please reach out and look at these devices before your providers have questions on scene. This device works very well and the need to chemically restrain patients have dropped drastically where they have been used.

Bill: VVFD has started the Narcan Leave behind program.

Ivan: Brought to everyone's attention that although Handtevy is built to the CAREMS guidelines, VVFD missed an IM fentanyl dose during review, this has since been corrected. A discussion was held about the high cost of Handtevy and how CWFD has not renewed, using CAREMSG app.

NEXT MEETING: Will be decided on for 2024 at a later date.


07/07/2023 Prehospital Meeting for July is cancelled as no one had any agenda items.
